- 3. I am at least 1.58m tall;
- 4. I am not married and never have had a marriage annulled;
- 5. I am not engaged;
- I have never given birth to a child, am not a parent, have never been pregnant and will not be pregnant at the time of the Pageant;
- 7. I am born as female;
- 8. I do not have any visible tattoos;
- I am of good moral character and do not have any criminal record:
- I am responsible for my own possessions while at the Pageant. The Organisation and its staff are not responsible for any of my personal belongings;
- I will be honest, show humility and respect and also be a role model and a legacy with pride;
- 12. I hereby agree to the time of submission of the application;
