(5) If I am shortlisted, I authorize producers to conduct background checks in order to verify any of the information I have supplied.

(6) All decisions by the producers concerning the selection of the contestants are final and no reasons will be made available to the applicant – I agree not to challenge or appeal those decisions.

(7) I will keep strictly confidential and will not, without the prior written consent of the Producers, at any time from the date I sign this application form and for twelve (12) months following the first transmission on television of the final episode of *Frenzy XTRA*, disclose, publish or reveal to any person, any incident, conversation or information concerning the series or the application/selection process which comes to my knowledge as a result of my inclusion in the participant selection process and/or the *Frenzy XTRA* series, if selected, nor other information relating to the other participants, consultants, sponsors or partners acquired by me during this period, without consultation with the publicity organs of the Producers or any of the participants and consultants, sponsors or partners.

(8) I am not an employee of Namibian Broadcasting Corporation (NBC) or Namib Mills.
