The document referred to in section **50(2)** below of the Act including a valid SME Certificate as well as-

1. Certified copies of incorporation documents, namely –
  - a) In the case of private or public companies, Form CM2, CM2A, CM2C and CM29;
  - b) In the case of close corporations, CC 1 (the founding statement);
  - c) In the case of trusts, sole proprietors or joint ventures, document equivalent to those referred to in paragraph (a) and (B) above,

To confirm the name of the entity, line of the business, companies or entities name, names of directors, partners and stakeholders as well as their nationalities.

**Section 50(2)** A bidder or supplier is disqualified from bidding if such bidder or supplier-

- a) Is not in good standing with the Receiver of Revenue;
- b) Is not in possession of a valid certificate of good standing with the Social Security Commission or, in the case where a company has no employees, confirmation letter from Social Security Commission;
- c) Is not, as required by the Affirmative Action (Employment) Act, 1998 (Act no. 29 of 1998), in possession of-
  - i. A valid affirmative action compliance certificate issue under section 41 of the Act;
  - ii. An exemption issued under section 42 of that Act; or
  - iii. A proof the Employment Equity Commissioner that the bidder or supplier is not a relevant employer as defined in that Act; or
- d) Has not submitted a written undertaking as contemplated in section 138(2) of the labour act.
